KlimaInvest CLIMATE NEUTRAL 2020/12

- The catalog contains emissions from organizations, products, services, events, logistics or other activities to be defined, which are offset through international, certified climate protection projects.
- All climate-damaging gases (emissions) such as CO₂ or CO₂ equivalents (CO₂e, e.g. methane gas) are compensated by the establishment and support of internationally recognized and certified climate protection projects.
- The compensation projects can be in the fields of wind, solar, hydropower (also tidal power plants), sustainable biomass (no food), methane gas avoidance, reforestation and forest protection.
- The certification period is normally one year. A different period can be defined if necessary. Retrospective certification and issue of certificates is also possible by arrangement.
- The audit considers a period of two to three years in total (current delivery year, previous delivery year and, if applicable, the year before).
- The carbon footprint is determined using recognized criteria/methods for calculating and measuring greenhouse gas emissions (Green House Gas Protocol (GHG), KlimAktiv, Gemis).
- The total amount of the determined emissions must be fully compensated.
- There must be process documentation from the first inquiry to the invoicing of the service rendered in the form of a documentation system that can be viewed on demand.
- Basis for the certification is a monitoring report with the following content:
 - Information about the company to be certified
 - Certification period
 - Description of the activities to be certified
 - Detailed description of the processes
 - Detailed description of data evaluation and data analysis (e.g. carbon footprint)
 - Information on the data used (emission factors, sources, projects etc.)
 - Calculation of emissions and compensation
 - Responsibilities with regard to climate-neutral products
- In the event of termination, at least one final audit must be conducted to ensure that all settlements have been properly performed within the certified period.
